FHA Revised Residency Requirements

Truist Bank (Truist) announces alignment with the Federal Housing Administration's (FHA's) recently announced revisions to residency requirements.

Effective Dates

Effective for FHA case numbers assigned on or after May 25, 2025.

Background Information

On March 26, 2025, FHA published Mortgagee Letter (ML) 2025-09, Revisions to Residency Requirements. This letter aligns FHA's residency requirements with recent Executive Orders that prioritize the use of federal resources to benefit U.S. citizens and ensures the integrity of government loan programs.

Bulletin Details

The updated residency requirements will remove eligibility for non-permanent resident borrowers from accessing FHA-insured mortgages by eliminating in its entirety the "Non-permanent Residents" category. This means that only U.S. Citizens, Permanent Resident and citizens of the Federated States of Micronesia, the Republic of the Marshall Islands, or the Republic of Palau are eligible for FHA-insured financing.

Lenders should consult with their Direct Endorsement (DE) underwriters with any questions.
