2026 Loan Limits Increase for FHA Loans

Truist Bank (Truist) is pleased to announce implementation of the increased 2026 Loan Limits for FHA products.

Effective Date

The FHA Forward Loan Limits are available for case numbers assigned on or after January 1, 2026.

Background Information

The Federal Housing Finance Agency (FHFA) recently announced an increase to the 2026 conforming loan limits. In response to this announcement, we are implementing the increased 2026 loan limits.

Bulletin Details

FHA Forward Loan Limits

The FHA national **low cost** area Mortgage limits are set at 65% of the national conforming limit of \$832,750 for a one-unit property. The FHA national **high cost** area Mortgage limits, are set at 150% of the national conforming limit of \$832,750 for a one-unit property. The Mortgage limits are, by property unit number, as follows:
